This form is to be used for listing all new animals which are being nominated for recording on the MBR register.

A "base" female is one that has not been previously recorded with the Angus Society.

NB. There is no facility to include DAM IDENTs of Base MBR females. Any dams which you wish to include must themselves first be listed as Base MBR females.

STEP-BY-STEP INSTRUCTIONS

- 1. Enter your **HERD ID** in the allocated space at the top of every page. This is the 3 letter code allocated by the Angus Society to your herd.
- 2. The following information **MUST** be provided for every nominated cow or heifer:
 - (i) COW/ HEIFER IDENT Each animal must have a unique IDENT comprising HERD ID (3 letter Herd Identifier), YEAR CODE and ANIMAL NUMBER (i.e. ear tag or tattoo number)

The YEAR CODES corresponding to each year of birth as listed in the following table:

- (ii) BREED COMBINATION CODE: An 8 letter code describing breed composition of the animal. Most animals are likely to be non-straightbred Angus. Examples of valid breed combination codes for non-straightbred Angus animals include:
 - Angus x Hereford : AA AA HH HH
- Poll Hereford x Shorthorn: PH PH SS SS
- Angus x (Angus x Hereford): AA AA AA HH
- · Angus x (Charolais x Brahman): AA AA CC BB

Other breed combination codes can be made up from the following standard NBRS breed codes:

- Poll Hereford: PH
- Brahman: BB
- Simmental: SI
- · Charolais: CC

- Friesian: FF
- Murray Grey: MG
- Shorthorn: SS
- · Hereford: HH

- · Limousin: LL
- · Salers: SL

Please contact the Angus Society for other breed codes or breed combination codes.

- (iii) BIRTH YEAR: The year of birth of the heifer or cow.
- (iv) CALVING SEASON: The season the female will calve in:

Autumn = 1 January to 30 June, and Spring = 1 July to 31 December.

- 3. The following information is **OPTIONAL**, but where it is known it should be provided to improve the accuracy of genetic evaluation of MBR animals.
 - (v) BIRTH DATE (dd/mm/yy): Actual date of birth (if known)
 - (vi) SIRE OF THIS COW/HEIFER: The sire's IDENT and NAME (optional), as recorded with the Angus Society. Only valid Angus Society IDENTs are acceptable.

If the sire is recorded with another Breed Society (e.g. in the case of crossbred or composite animals having non-Angus sires) then contact the Angus Society to obtain the Angus IDENT to be allocated to that sire. The Angus Society will maintain a cross reference of sires of otherbreeds which are also recorded with other breed Societies. This information will be important in the future calculation of across-breed EBVs.

- 4. AS PER ANGUS AUSTRALIA REGULATION *6.37: It shall be a requirement for the registration of all animals in the HBR, APR, ACR or MBR whose sire is born on or after 1/1/2004, that their sire has a DNA profile recorded with the Society. If then sire is born after 1/1/2018, the DNA profile must be a SNP profile with a minimum of 5,000 SNPs.
- 5. The bottom of each page must be signed by the authorised signatory for the herd.
