



Terms and Conditions for the AngusEXPO Elite Angus Female Sale

1. Eligibility

Participation in the sale is open exclusively to financial members of Angus Australia and the Red Angus Society of Australia. Eligible entries must be registered in one of the registers of Angus Australia or the Red Angus Society of Australia. Entries are only open to exhibitors at the Zoetis AngusEXPO, who may submit a maximum of one entry.

2. Entries

Entries will be reviewed upon the close of submissions on or before **7th March 2025** by Elders and Angus Australia. If entries exceed the capacity of the planned physical sale, an alternative sale method will be advised at the close of entries. Elders and Angus Australia reserve the right to review entries and place any limits as deemed necessarily for the successful outcome of the sale.

3. Entry Fee

Each entry has a fee of \$1,000, with \$500 charged through the membership account at the time of entry and the remaining \$500 payable upon the successful sale of the female at auction or immediately following the sale if completed through Elders.

4. Lots

Lots may consist of individual females, pick of the pair, pick of the pen, or a share of an individual animal. The lot description must be clearly specified at the time of entry.

5. DNA Testing

- **Sire Verification:** Mandatory for all sale entries and must be confirmed in the Angus database by **31st March 2025**.
- **Genomically Enhanced EBVs:** Animals must have genomically enhanced Estimated Breeding Values (EBVs) published through the TACE analysis by the April 2025 TACE publication. This requires either an HD50K or AngusGS test. Vendors are strongly encouraged to complete these requirements early.

6. Health and Breeding Status

All sale entries must:

- Be **PI-negative** and vaccinated in line with Zoetis's immune-ready guidelines. Certification of PI-negative results must be submitted at entry via a veterinary laboratory certificate or results from Zoetis or Neogen.
- Provide a **breeding soundness certificate** from a registered veterinarian and a **pregnancy status certificate** (in calf or empty) by **31st March 2025**. This certificate must be current, dated within 30 days prior to sale.

7. Inspection

Each female will undergo inspection at the AngusEXPO at a specified time on-site by Elders and a representative of Angus Australia. Inspections will verify:

- Two forms of permanent identification (brand, tattoo, NLIS) and breed character.

Vendors must provide:

- A **National Vendor Declaration (NVD)**.
- An **Animal Health Declaration**.
- A copy of the breeding soundness certificate, dated within 30 days prior to the sale. Failure to meet inspection requirements may result in exclusion from the sale.

8. Promotion

- Entries will be catalogued by Angus Australia, with distribution via the Angus SaleSELECT feature online and Auctions Plus with printed copies available through Elders and Angus Australia.
- Vendors are strongly encouraged to submit professional sale videos and photos following these guidelines:
 - **Deadline:** Videos must be uploaded to Angus Australia's OneDrive file by **17th March 2025**.
 - **Content:** Videos should begin with a side view of the animal and include footage of the animal walking side-on, towards the camera, and away from the camera. A side-on photo of the animal in a natural, stationary position must also be included.
 - **Specifications:** Videos should be no longer than 2 minutes, without music, captions, or graphics.
 - **Presentation:** Animals must be walked off halter, with no visible pedigree or stud names as well as a clear background free of any rubbish or distracting objects.
- All lots will be listed on Auctions Plus by Angus Australia

A list of professional livestock photographers is available upon request.

9. Sale Management

Angus Australia reserves the right to oversee and direct all sale-related activities. Participants must comply with directives from Committee representatives.

10. Transport following the sale

Falls Transport has been appointed as the stud stock transporter to handle logistics following the sale. All cattle need to leave AELEC on Monday the 5th of May. Unless written instructions are provided with alternate advice, all lots will be coordinated by Falls Transport on behalf of the purchasers.

10. Medication

Vendors must inform selling agents (Elders) of any antibiotics or anti-inflammatory treatments administered within 14 days of inspection using the provided Treatment Schedule Form. The Committee reserves the right to conduct drug or medication testing at any time.

11. Ringworm

Animals showing signs of ringworm at inspection must present a veterinary certificate confirming the ringworm is inactive. Failure to do so will result in rejection.

12. Acknowledgement, Release & Indemnity

By entering, exhibitors agree to:

- The Committee and its representatives bearing no liability for any actions or omissions.
- Participation being entirely at the exhibitor's own risk, including any injury, death, property damage, or economic loss.
- Release and indemnification of the Committee and its representatives from any claims arising from participation.
- Indemnifying the Committee against claims resulting from the exhibitor's actions or omissions.

13. Condition of Cattle

The organisers do not guarantee the condition, quality, or performance of cattle offered for sale and are not responsible for injury or death of cattle. Vendors indemnify the Committee against any claims regarding cattle health or performance.

14. Vendors' Guarantee on Females

- Females sold as unjoined are warranted to be fertile for natural service within 12 months of the sale.
- If fertility issues arise, vendors must refund the purchase price upon receipt of a veterinarian's report confirming the issue is unrelated to illness or injury post-sale and no embryo transfer procedures were conducted.

- Vendors must disclose if the animal has been previously flushed or is selling as a shared interest, including possession rights.
- Females previously flushed must be disclosed in the catalogue comments section.

15. Reserves

A suggested market floor price will be collected during the entry process and reviewed by Elders. Vendors may confirm or negotiate reserves with Elders at the time of inspection.

16. Commission

Elders will retain a **6% commission** on all lots sold under the hammer or via Elders immediately following the sale.
